| WHEREAS, the COMMISSIONER and the MUNICIPALITY have entered into an Agreement No. <u>D014730</u> entitled "Indexed Lump Sum Snow and Ice Agreement between the New York State Department of Transportation and the Municipality of <u>Town of Lewiston</u> dated <u>May 16, 2006</u> ; and | | | | | |
| WHEREAS, the term of the said Agreement is for a period of three years commencing 2005 and the said Agreement provides that the parties may at the end of each year of the term of the Agreement extend such term for an additional year; and | | | | | |

The State Highways or parts thereof affected by this Agreement are as delineated on the attached map, agreed upon by the COMMISSIONER and the MUNICIPALITY, which shall be effective for the remainder of the term of the Agreement commencing July 1, 2017 , unless changed by future agreement between the COMMISSIONER and the MUNICIPALITY. | | | | | |
| 3. All the terms and conditions of the original contract remain in effect except as follows.
