Dear Town Board Members:

I am writing this letter to request permission to dig a pond towards the back of my lot to properly grade my back yard and resolve its standing water issue. When I purchased the lot at 4831 Creek Road it was below the grades of the adjacent lots. Standing water was major problem. The front 200 feet of the lot was properly graded with 50 tandem loads of clay and dirt costing over \$10,000.

I would like to dig a 40-foot pond at the back end of my lot so that I could use the clay to properly grade the remaining 400 feet of my lot. No clay would be taken off location, only moved around to fix my lot. I have enclosed pictures of my backyard so that you can see the standing water problem. I also enclosed an areal view of my lot with the proposed location of the pond and where the clay would go.

Honorable Members of the Lewiston Town Board,

Please approve a motion to allow the Recreation Department to pursue funding from the Niagara River Greenway Committee for needed additions to Sanborn Park.

Sanborn Park is a previously approved location for Greenway funding, and this project should be added to narratives approved for improvement projects completed in 2011 and 2012 at this Park.

This request will include funding for:

1. Handicap Accessible Pathway (\$15,000)

This path will be in either concrete or sealed asphalt, depending on material and labor costs after bidding. It is our preference to complete the project in concrete for maintenance and durability. This path will connect the north parking lot (Tallman) and Elm Street, as well as connections to each playground, bathrooms, ice rink, and basketball court, providing community access to each station in the park. In total, the path is 510 Linear feet.

2. Installation of LED Lighting (\$13,500)

This will install three high density LED lights along the pathway in the Park. The installation of these lights will allow the Recreation Department to offer some illumination during evening activities on the basketball court, playground and Ice Rink, as well as providing adequate light to discourage vandalism in the park and promote safety. Please note that a similar light was installed at Colonial Village Park and has been successful in those goals.

3. Bathroom Restoration (\$45,000)

Sanborn Park currently has sewers and infrastructure in place for indoor bathrooms within their storage building (Pictures Enclosed). This project would install new fixtures, lights, and electric service to allow these bathrooms to be opened to the public during normal Park hours. We would also be installing flooring and tile as well as cosmetic upgrades within the scope of work.
