Supervisor opened meeting at 6:07 p.m., followed by the Pledge of Allegiance and a moment of silent reflection.

Approval of Abstract

<u>Palmer MOVED to approve the Regular Abstract of Claims numbered 3,433 to 3,707</u> and recommend payment in the amount of 271,856.55, plus a Post Audit of 53,129.92, Seconded by Bax and Carried 5 - 0.

Approval of Post – Audit

<u>Palmer MOVED to approve a post audit payment to HSBC Bank USA, N.A. in the amount of \$1,637.52, Seconded by Bax and Carried 5 – 0</u>.

Demolition of House – Request RFP's – 958 Ridge Road

958 Ridge Road burned in 2002 and has been left in that state since. The owner has been notified by certified mail that if an engineered plan, building permit and contractor with start day aren't secured by November 15th, the building department is requesting permission to demolish the house the week of November 15th. The house has been in violation since 2002, been to court at least twice and the owner has failed to respond to court directions.

The building department received three bids for the demolition. Mark Cerrone bid \$8,400; Empire Dismantlement Corp. bid \$23,000 and Robert MacVie Inc. bid \$5,770. In addition to the quote, there will be an additional charge of approximately \$1,000 for an asbestos survey. The low bidder on the house is Robert MacVie Inc. of \$5,770, plus the asbestos survey to be put on the property taxes for 2011.

Bax MOVED to demolish 958 Ridge Road and accept the bid of \$5,770, from Robert MacVie Inc., plus asbestos survey to be put on the property taxes of 2011, Seconded by Marra and Carried 5 – 0.

Masters said three homes have been demolished. Other properties are being looked at.

Set Public Hearing – WPCC Increase & Improvement of Facility - Bax requested to table for further information.

Sanborn Lights Streetscape Bids

Three bids received and opened on November 1st. Gexpro bid \$52,200; Rexel bid \$52,000; Shanor Electric Supply Inc. bid \$42,721.85. Bids are for lighting fixtures themselves, and within the Streetscape budget.

<u>Marra MOVED to accept the lowest bid of Shanor Electric Supply Inc., in the amount of \$42,721.85, Seconded by Palmer and Carried 5 – 0</u>.

Palmer said the Board has been informed that items are being purchased without being signed-off by the Finance office first. Palmer requested a copy of the Procurement Policy, approved by the Board in January be forwarded to all department heads requesting they adhere to the process.

<u>Palmer MOVED to instruct all department heads to adhere to the Procurement</u> <u>Policy and all purchases are to be signed-off by Michael Johnson first, Seconded by</u> <u>Marra and Carried 5 - 0</u>. Reiter and Johnson will be having an employee meeting to discuss budgets and the health insurance coverage.

Reiter announced that on November 10th the New York Power Authority and its partners in the New York State Office of Parks; Recreation & Historic Preservation will hold a groundbreaking ceremony to launch the project at Reservoir State Park at 1:00 p.m.

Johnson updated the Board on the energy audit done at the highway garage, Town Hall and Senior Center. If the Town pre-pays, rather than having it come off the bill, it will cost \$276.51, with an annual savings of \$828.60. Johnson asks for permission to have the Supervisor sign the agreement with Lime Energy.

<u>Winkley MOVED to authorize the Supervisor to sign the agreement with Lime</u> <u>Energy, Seconded by Bax and Carried 5-0</u>.

<u>Marra MOVED to enter into Executive Session to discuss Litigation and Health</u> <u>Coverage, Seconded by Bax and Carried 5 – 0</u>. (6:20 p.m.)
