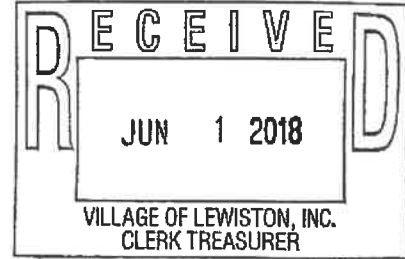

Dear Mayor Collesano,

New York State recently passed legislation requiring all fire companies, departments and districts to carry cancer insurance for all volunteer firefighters that are certified interior qualified beginning January 1, 2019. It is estimated that the cost of this coverage will be no more than \$ 300.00 per firefighter and we presently have 32 interior qualified members.

Under paragraph 8 of our contract, the Village has agreed to cover these unanticipated governmental mandated costs. We have asked our insurance provider to provide us with information as soon as it is available.

I have attached an information packet of the required coverage.

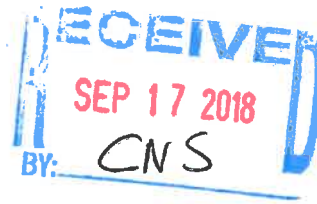
